Figure 23.1.1 Major Classes of Organic Compounds The first family listed in Figure 23.1.1 "Major Classes of Organic Compounds" is the hydrocarbons. These include alkanes, with the general molecular formula $C_n H_{2n+2}$ where n is an integer; alkenes, represented by $C_n H_{2n}$; alkynes, represented by $C_n H_{2n-2}$; and arenes. Halogen-substituted alkanes, alkenes, and arenes form a second major family of organic compounds, which include the alkyl halides and the aryl halides.
